## POLICE BENEVOLENT ASSOCIATION CHARITY FUNDS SCHOLARSHIPS

### Police Benevolent Association Charity Fund Scholarship

(Must be a son/daughter of an **active** PBA Member EMPLOYED by a qualifying Law Enforcement Agency but **not employed by PBSO**)

### Kaitlin A. Kazanjian Memorial Scholarship

(Must be a son/daughter of an **active** PBA Member employed by **PBSO**)

#### Eligibility Requirements:

1. Child (under the age of 25) of a Palm Beach County PBA member with a minimum of 5 years membership or have prior Board approval. Children of Retirees are NOT eligible to apply. Grandchildren of PBA members are NOT eligible to apply.
2. Be, or plan to be, a part-time or full-time student at an **accredited** two-year or four-year college. Graduate students and students that have already received four (4) scholarships from any of the PBA Scholarship Funds are not eligible to apply.
3. Include an essay, no more than 500 words, about yourself, college/career goals, and your family. **Essay must be double spaced** in 12-pt font Arial or Times New Roman ONLY!
4. Provide letter of acceptance (*unless your transcripts are from a qualifying college or university*).
5. Provide or have delivered, official transcript with GPA (can be provided after deadline).
6. Send all documents to PBA Scholarship Committee, 2100 North Florida Mango Road, West Palm Beach, Florida 33409.

**DO NOT** submit any photos, resume`s, letters of recommendation. **DO NOT** bind in any way.

**Note:** Should the recipient of a scholarship fail to enroll and/or attend a qualifying college program within eight (8) months after receipt of funds, the full amount of the scholarship shall be returned to its appropriate Fund or, otherwise, be subject to collection.

**ABSOLUTELY NO EXCEPTIONS**

INITIAL Is application typed or printed clearly with contact phone number for applicant?

INITIAL Is application signed **AND** dated on each page by **both** applicant and member/parent/guardian?

INITIAL Is essay included (double spaced in Times New Roman or Arial 12-pt Font)?

NOTE:

- Submit only one (1) application;
- You may be contacted for in-person interview;
- If you do not have letter of acceptance and/or transcripts, we will contact you for them later. **DO NOT DELAY** submitting in your application and essay!
