### **EVERLASTING LOVE -**

An emotional tribute to Luis Paez, Butch Waller and Dan Diaz with the honor and reverence from the Palm Beach County PBA, the Palm Beach County Sheriff's Office and a grateful community.

So this story could go on forever, and maybe it should, because Palm Beach County PBA President John Kazanjian promises the honor, the praise and the love for Louie, Butch and Dan will continue for at least that long. From South Florida to every corner of the state and all the way to the White House.

The emotional, blessed, loving response reverberating through the PBCPBA, the Palm Beach County Sheriff's Office, its heartbroken but undaunted motors unit and a devastated community will be never-ending. From just minutes after the tragedy on Nov. 21, 2024, that took PBSO Corporal Luis Paez, Deputy Ralph "Butch" Waller and Deputy Ignacio "Dan" Diaz until forever.





By 11 a.m. that day, hundreds of law enforcement officers from PBSO, hundreds more from Palm Beach, Martin and Broward counties and a multitude of fire rescue and EMS had gathered at St. Mary's Medical Center in West Palm Beach. Not wanting to believe that what they heard about "motors down" was not the ultimate word about Louie and Butch and praying that Dan would come out of being critical.

The PBA Grill Team started sending food for all of them at the hospital. "We sent food everywhere for days," Grill Team leader Ray Griffith confirmed, his voice fading and the tears audible as he recalled the ordeal even more than a month after it occurred.

For the Dec. 3 memorial service at the iThink Financial Amphitheater in West Palm Beach, the PBA Grill Team that Griffith leads as a retired PBSO officer, began setting up a day before and cooking at 6 p.m. the night before. They needed a full day after the memorial to break down, and ultimately they served more than 2,000 pounds of pork butts and probably 6,500 people.

Within less than 24 hours of the tragedy, the PBCPBA took on orchestrating fundraising and organizing donations for the Paez, Waller and Diaz families. The union set a goal of raising \$300,000 and met that within three weeks following the memorial service. So at the Dec. 10 PBA Board of Directors Meeting, they doubled down to get \$600K in the bank before Jan. 15. And topped that number before mid-January.

That does not include the \$77,000 Kaz procured that the Florida State PBA and PBCPBA provides to families of officers lost in the line of duty.

"A lot of other unions can't do that but thank God we have the facility to do it," Kaz commented. "We open the doors, and they poured in from all over. They really saw how we come together."

By the afternoon of Nov. 21, the PBCPBA opened its doors as a hub for motors unit officers and PBSO deputies from across the county to gather, rest, breathe and grieve. Motors Unit Sergeant Cory Gray, a longtime PBA rep, explained how the unit went to the PBA Hall to have what would be the start of feeling the healing.

And if the families needed something?

"Kaz gave me the PBA credit card," Gray continued. "He's like, 'Get the family hotel rooms, they need flights here, whatever the families need, food, you get them," But it was about more than credit cards, checks and pork butts. For every member, every officer and every family member, here was the priceless value of being there. That was the perspective PBSO PBA rep Jeremy Campbell observed sitting among his fellow officers in the PBA Hall.

"A lot of people showed up and they just sat there, broke bread, laughed and enjoyed each other's company," Campbell described. "And some of them cried."

## Now and Forever



The "gut punch," as Kaz called it, of losing three officers in one incident is still almost too hard to believe. Gray recalled being in the PBSO Vehicle Homicide Investigation office when he heard on the radio "We got three motors down."

Three down had to be three bikes out of commission due to mechanical problems or something more mechanical. Like so many other officers in and around the department and other first responders, he called dispatch for the location.

When Gray arrived, he saw CPR being administered.

"You're like, 'Are you dreaming? Is this really happening?" Gray explained. "And you see the guys, your friends, and they're helpless, and we're trying everything to save their lives. I'm giving myself chills right now just talking about it."

Calls and texts from deputy to deputy kept asking for details – more than just Louie, Butch and Dan had been hit by a car. Were they in traffic or what?

When the details came, a shock burst down the collective spine of Palm Beach County law enforcement. Palm Beach County Sheriff Ric Bradshaw echoed the are-you-sure reaction of each of the 4,000-plus in the department.

At the sheriff's watch party on election night, he had seen all three officers. Even took a picture with Deputy Waller and recalled how they had to jet because they were working President Trump's motorcade taking him from Mar-a-Lago to the convention center.

And two weeks later, Bradshaw had to report that Louie, Butch and Dan were all working traffic detail on Southern Boulevard near Seminole Pratt Whitney Road in Loxahatchee clocking cars running eastbound. Not uncommon to have three motormen on such a detail as the sheriff noted.

After stopping a motorist, one of the bikes would not start. The other two officers came to help get it restarted.

A woman driving eastbound was in the center lane when she came upon a vehicle going much slower. She veered to the right and, according to Bradshaw, overcompensated, went off the road and then struck all three of the motor officers.

"All three went airborne in different directions," Bradshaw explained. "You can train the deputies to deal with bad guys You can train the deputies for traffic stops. You can train the deputies for high speed chases, how to deal with people. There is no training for this. They never had a chance to do any evasive action. They never had a chance to try to save themselves."

By the time Campbell made it to St. Mary's Medical Center, Dixie Highway had to be closed down because of all the police cars and personal cars coming. The magnitude of the tragedy kind of grew from here.

"Just hundreds of officers from the sheriff's office, from FHP, from the city, municipalities, Broward County," Campbell detailed. "There were patches that you didn't even recognize because you don't see 'em here in Palm Beach County."

Magnitude hit Bradshaw almost immediately after the incident. President-elect Trump called first. Then JD Vance. Then Governor DeSantis. The FBI and Secret Service directors called next, as well as more U.S. Senators and Reps than he could recall.

Bradshaw also made the statement that seemed to put it all in perspective.

"A piece of the community died," he said.

### **Perpetual Emotion**

Almost moments after the tragedy, Kaz put the works in motion to secure \$77,000 to each family so they would not have to worry about meeting expenses. Moments later, PBCPBA Secretary Mike Kennedy, a PBSO lieutenant, put out the word to offer an abundant supply of support, like getting EAP for the motors unit and what Gray described as booking weeks and weeks of hotel rooms for the family or whoever needed them.

Providing for grieving and breathing and family support for the rest of their lives generated acts of kindness that will be equally never-ending as far as the PBA is concerned. Acts that enable the union to accentuate a big, bold B for "Benevolent" in PBA.

"Us coming up with some financial help, it's not the cure all, but it kind of lessens, I guess, the blow," Kaz began.

But benevolence is much more personal than that, and few know how much more than the PBA president. The neverending empathy is this:

"Don't hesitate to reach out and talk to me," Kaz invited. "Whatever you need. We'll go out to dinner. I don't care. Whatever it is, whatever we can do to help."

Benevolence reached unprecedented levels when the PBA spread the word that set fundraising in motion to help the Paez, Waller and Diaz families. Campbell related how the goal escalated like flashes on a tickertape: \$100,000...\$150,000...\$200K... \$300,000. And counting.

Community contributions began like all Chick-Fil-A stores in Palm Beach County, Treasure Coast Mall, and Fort Pierce donating a percentage of the sales to the charity fund. Sean Hannity featured the charity fundraiser on his show, and all local news outlets shared the QR code on air for donations.

The donations continued to blow up, including:

- Bolay Kitchen's statewide fundraiser at all locations the entire weekend of Dec. 13-16.
- Lilly Lovers of the Palm Beaches selecting PBA charity fund as their charity of the month for December.
- Tropically Impaired, which makes clothing, headwear and accessories designed special T-shirts for the fallen officers and is donating 70 percent of the proceeds to the charity fund.
- Longtime PBA benefactor Richard Tschernia donated a five-day Bahamas trip for raffle tickets selling at \$100 each designed to raise \$50,000.
- Zuccarelli's West Palm Beach held a day with raffles, percentage of sales and other fundraising acts on Jan. 5, an event that has generated \$10,000 and counting.
- Boonies did a fundraiser with We Fund The Blue Foundation and presented the PBA with a check for \$10,500 in early January.
- Village Walk of Wellington has scheduled a benefit concert on Feb. 22 with 100% of all donations, ticket sales, raffles and auctions going to the fund for the families. And it's sold out, which could be another \$10,000 donation.



to the PBA asking, 'How do I donate?'" Kaz confirmed. "It came from all around the country. They saw what type of tragedy we went through on our website, Facebook, Instagram and the donations just started rolling in."

And contributions like LazerWerk Memorial Bracelet

added to the fund but sent out tributes to Louie, Butch and

Almost moments after the tragedy, the PBA lent additional support as only the union can. Griffith said as soon as he heard that Louie, Butch and Dan were being airlifted to St. Mary's, he loaded up a cooler with provisions and headed to the hospital. And so began a marathon of serving food, drinks, snacks that means so much to the families and the deputies in times like these.

"So right away I had the crew load up some coolers because there'd be 100 people at the hospital before you know it. And by the time I got there within an hour, it was already that big," Griffith noted. "Anytime I was asked for anything, I mean, I was married to this phone for damn near two weeks straight."

By the afternoon of Nov. 21, the PBA Grill Team had the union's hall set up to serve all officers in the miles-long motorcade taking Louie and Butch to the ME's office. It was a debriefing and breadbreaking, the bookends for the safe space that PBSO and other responding agencies needed.

It's hard to think of everything, but this service came pretty damn close. Like making sure to keep everybody hydrated up to and through the memorial service.

"I'm not talking a cases of water, I'm talking pallets of water," Griffith said. "It took a small army to get done what we did. Honestly, from my heart, I tell you, I don't know how the hell we did it. But we did it."

The army included responders from across the country, many of them PBA. The New Jersey State PBA, for example, sent its food trailer to be on site for the memorial. Griffith reported their service included making hundreds of breakfast sandwiches and serving hot chocolate, which he said proved to be vital on this cold morning.

A group of retired cops set up a water tent. Broward County firefighters brought a trailer to get waters to thousands of people who had to park far from the entrance. And this part of it, too, seemed never-ending.

"You don't get tired. You don't have time to be tired. You just do it. It's really monumental," Griffith admitted. "This is nothing like the barbecue we do at Trump National for the PBA golf tournament. This is on a new level man that you don't want to think of it because it hurts."

The PBA Hall became more than just a place for PBSO deputies, and specifically motormen, to refuel and recharge. With the way his officers were hurting, Lieutenant John Chapman praised how the opportunity to come to the hall allowed for the fellowship and camaraderie that began the healing process.

"It's the union wanting to just make sure the folks are taken care of and that was the message that was delivered," Chapman stated. "Their job is to represent and protect us. And one of the ways they do that is with that constant presentness and just letting the folks know they're there. And they're doing it by their actions."



### ENDLESS LOVE

So coming to the end of this particular tribute to Louie, Butch and Dan, it's plain to see how the love will go on forever. Starting with the response from President Trump.

All three motormen worked the presidential motorcades from Trump's first election up to the night he was re-elected and beyond. Gray reported how the President reached out as soon as he heard about the tragedy asking about what he could do to help. The 7,000 who attended the memorial saw President Trump on stage behind his protective glass next to his son, Eric, a longtime PBCPBA friend, feeling the emotion of the tributes.

"Those guys loved the honor to be a part of the presidential escorts, and they did a phenomenal job with it," Lieutenant Chapman said. "The President was engaged that entire time of the service, which I thought was the utmost respect."

An unimaginable sign of respect that seemed to go on forever was the number of motors officers who came from across the country and lined State Road 7 and Southern, Crestview and Okeechobee boulevards as the three officers were carried to the iThink Amphitheater. Accounts from the scene called this, and the line of bikes running six or seven miles after the memorial, the largest motors escort ever assembled.

"Oh my God. The motorcycle procession itself. I would say at least six, seven miles at least," Campbell described. "The furthest west that I saw was California Highway Patrol motorcycles, as well as upstate New York and Texas Ranger motorcycles were there. I mean you saw every state represented at that funeral."

That said, let's offer a final bow to the deputies U.S. Rep Brian Mast simply praised when he spoke at the memorial service by saying, "They were lions."



Corporal Luis Paez, Motor 4 who dedicated 36 years to serving with PBSO, never had a day when was heard pouting or bitching about the job. Except for a few deputies, Corporal Paez trained every single member of the motors unit.


Gray was one of those 18 years ago. He remembered Louie as having a little hard-ass in him, but nearly every word he said in training had something to do with safety. When Gray returned to the unit as a sergeant recently, he would consult Louie about right decisions about Trump escorts and every other detail.

In 2009, Louie was the motors school teacher for Ryan Mugridge, who is now the motors unit Captain. And the influence Louie had on Mugridge as his field training office never waned.

"So I kind of refer to him as my unofficial leader or Papa Smurf if you will, where you just go to somebody who has almost all the answers," Mugridge added.

Chapman confirmed what Mugridge saw in Louie.


"He was looked up to as the father of the unit," Chapman said. "Not necessarily a sheep herder, but more of you go to him for the advice."



Deputy Ralph "Butch" Waller, Motor 7, was known as the "mayor of Royal Palm Beach," having worked as a motor there for eight years beginning in 1998, before becoming a PBSO deputy when the department moved into the sheriff's office. He was known for a quirky sense of humor, and if he called you by his signature "Boo-boo," it meant you were one of his besties. Which was everybody.

Gray mentioned how a normal traffic stop would take five to six minutes. Butch's stops could extend to 40 minutes because of engaging motorist in conversation that was the best type of community policing. He was equally renowned for being the type of mentor who made everybody who talked to him feel like the most important person in the world.

"He never had a bad day. And when you were having a bad day, you just called Butch up, 'Let's go have coffee," Mugridge praised. "We would just laugh, and the laughter helped me cope with whatever I was going through that day. He was one of the shortest guys on the motors, but he had the biggest heart."





Deputy Ignacio "Dan" Diaz, Motor 18, started with the Palm Springs Police Department in 1996, became its first motorman and moved to PBSO in 2008. He worked in the DUI unit for six years, and used to report his score for how many DUI arrests he made during each year to his daughter, Alexandria. Making 100 DUI arrests in a year earned an award from the Mothers against Drunk Driving (MADD) and Dan received one every year.

He was known as that guy, the one who always had a blindingly clean, white shirt always tucked in and boots shined so fine you could see the reflection of his shirt. And for all his knowledge, Dan loved having a good cigar and being the life of the party.

"He had a strong, confident personality that was just, he could make the room laugh," Chapman remembered.

There will be many more opportunities to have a cigar and laugh when recalling Louie, Butch and Dan. Kaz said he is planning a tribute that promises to be full of love and emotion at the PBCPBA Officers Ball on April 5.

Within the brotherhood of motormen, one of the great events is a motorcycle rodeo. Riders get together and test the prowess of their skills through a series of challenges. PBSO, in partnership with the PBA, is planning to host an annual motorcycle rodeo named for its three fallen brothers that will raise money for charity and their families.

As for now, well, an entire community, profession and even county gathered on Dec. 3 to say farewell. At the end of the service, the words came over the radio and were piped in for all to hear.

Palm Beach is checking the channel for Motor 4, Motor 7, and Motor 18. To all units and listening agencies, the Palm Beach County Sheriff's Office will be observing a moment of silence in memory of our three fallen deputies. Corporal Luis Paez, Deputy Sheriff Ralph "Butch" Waller, and Deputy Sheriff Ignacio "Dan" Diaz.

And then dispatch ordered that Louie, Butch and Dan are now "10-7." But the honor, praise, remembrance and love, well, that will be 10-forever.

### Know Your Rights

If you are under investigation, remember, as a law enforcement officer, you have rights.

### They include:

THE RIGHT to have a PBA representative present during an interview (you must request one!)

THE RIGHT to know who's in charge of the investigation

THE RIGHT to know what the charges are and the name of the person bringing the charges

THE RIGHT to have the interview at a reasonable time and for a reasonable length of time

THE RIGHT to have any interview tape-recorded from start to finish

THE RIGHT not to be threatened or bribed or listen to offensive language

THE RIGHT not to be forced to resign

### PROTECT YOUR RIGHTS

The following statement should be written as the first sentence on any statement, report, or memorandum that an officer is ordered to write when the officer knows, or has a reasonable belief, that discipline may result:

It is my understanding that this report is made for administrative, internal police department purposes only. This report is made by me after being ordered to do so by lawful supervisory officers. I have not been permitted a reasonable amount of time to confer with a PBA representative or attorney. It is my understanding that by refusing to obey an order to write this immediately, I can be disciplined for insubordination and that the punishment for insubordination can be up to, and including, termination of employment. This report is made only pursuant to such orders and the potential punishment/discipline that can result for failure to obey that order.

### REMINDER

The legal defense policies of the Florida and Palm Beach County PBA have an important provision regarding representation. If a member elects to secure representation by anyone other than the PBA (a private attorney, for example), that member is considered to have waived representation by the PBA. Once this happens, it is the PBA's option whether or not to continue to represent the member in that matter. Please call the PBA office if you have any questions regarding this policy.

### THE BRIEF

### Forfeiture of Retirement Benefits Under Florida Law



In the State of Florida, it is possible for a law enforcement officer to forfeit their retirement benefits. The legal authority for a forfeiture action is grounded in the state constitution, which provides, "Any public officer or employee who is convicted of a felony involving a breach of public trust shall be subject to forfeiture of rights and privileges under a public retirement system or pension plan in such manner as may be provided by law." Art. II, § 8(d), Fla. Const. (emphases added).

Pursuant to Sec. 112.3173(3), Florida Statutes, "Any public officer or employee who is convicted of a specified offense committed prior to retirement, or whose office or employment is terminated by reason of his or her admitted commission, aid, or abetment of a specified offense, shall forfeit all rights and benefits under any public retirement system of which he or she is a member, except for the return of his or her accumulated contributions as of the date of termination." Forfeiture occurs upon proof of one of seven "specified offenses" that are narrowly limited to felonies involving serious offenses against a public entity or involving an abuse of authority amounting to a misuse of public office. "Specified Offense" is defined as:

- 1. The committing, aiding, or abetting of an embezzlement of public funds;
- 2. The committing, aiding, or abetting of any theft by a public officer or employee from his or her employer;
- 3. Bribery in connection with the employment of a public officer or employee;
- 4. Any felony specified in chapter 838, except ss. 838.15 and 838.16;
- 5. The committing of an impeachable offense;
- 6. The committing of any felony by a public officer or employee who, willfully and with intent to defraud the public or the public agency for which the public officer or employee acts or in which he or she is employed of the right to receive the faithful performance of his or her duty as a public officer or employee, realizes or obtains, or attempts to realize or obtain, a profit, gain, or advantage for himself or herself or for some other person through the use or attempted use of the power, rights, privileges, duties, or position of his or her public office or employment position; or
- 7. The committing on or after October 1, 2008, of any felony defined in s. 800.04 against a victim younger than 16 years of age, or any felony defined in chapter 794 against a victim younger than 18 years of age, by a public officer or employee through the use or attempted use of power, rights, privileges, duties, or position of his or her public office or employment position.

Sec. 112.3173(2)(e), Florida Statutes

Courts must strictly construe forfeiture statutes in "favor of the party against whom the penalty is sought to be imposed." <u>Braddock v. City of Port Orange Pension Fund's Bd. of Trustees</u>, 395 So. 3d 219, 223 (5th Fla. DCA 2024). Ultimately, only felonies that involve a "breach of public trust" are actionable and the legislature is empowered to provide "by law" the manner in which forfeitures occur. Section 112.3173 of the Florida Statutes implements this constitutional provision.

### **Social Security Fairness Act:**

### **Upcoming Changes to Laws Regarding Social Security Benefits to First Responders**



In January 2025, President Biden signed the Social Security Fairness Act, which eliminates the "Windfall Elimination Provision" and the "Government Pension Offset" sections of the laws governing Social Security. These prior provisions reduced Social Security benefits for certain retirees who also receive(d) pension benefits. Thus, the new law changes will increase Social Security benefits for some first responders and public sector employees, including law enforcement officers and firefighters who receive pension benefits.

Under the prior law that has been in effect for decades, certain people would receive reduced Social Security benefits due to their careers in public service (what may have been considered "non-covered" employment). For example, the "Windfall Elimination Provision" (WEP) meant that for those people who worked in government positions for which social security taxes were not withheld by the employer and who received pensions not paying into Social Security, those individuals' Social Security benefits were decreased. However, many of those people were unaware of this effect on their retirement benefits, and the provision negatively affected the retirement benefits for those people who worked other/additional employment positions that were eligible for Social Security retirement. The WEP was a formula used to calculate and adjust Social Security benefits for people who received "non-covered pensions" but who also qualified for Social Security benefits based on other covered earnings, and it considered earning types and contribution levels to determine coverage levels. In short, under the new law changes, there are no longer Social Security benefit reductions for those who also receive(d) pensions from positions where Social Security taxes were not withheld. Similarly, regarding the government pension offset, Social Security benefits sometimes were reduced or eliminated for spouses and surviving spouses who received government pensions of their own.

Multiple unions and not-for-profit organizations have fought decades-long battles against these reduction provisions, and the changes will impact many people across various fields of work, including police, firemen, nurses, and other state and federal workers. The law is effective for benefits payable after December 2023. We encourage you to look into if and how these recent changes may affect your own retirements benefits.

### WHERE IS THE "PRO" IN PROBATE?

Probate is a process that is used to transfer assets when a person has passed away. The problem is that probate is expensive in terms of attorney fees and court costs. The average case takes one year to complete or longer if there is a dispute. There are also many legal documents that must be prepared, signed and notarized, filed, served and so on. I don't see the "pro" in probate. This isn't something that you want your family members to be going through when they are dealing with a loss.

To avoid probate, a revocable living trust can be created. A trust helps to not only avoid probate but also to protect younger family members by including guardian provisions and ensuring that their money is distributed over time until they reach a certain age. It's a way to be a parent even if you're not here. In other words, a trust is something that you can create today that becomes a lifelong gift for your loved ones.

It is also important to note that an asset that has been transferred into a trust can pass immediately to the beneficiaries upon the death of the settlor (person who makes the trust). There are also important protections within the language of the trust that arise for the beneficiaries once the settler has passed away. The same is not true for probate.

As you can see above, there are many "pros" to a trust when compared to going through probate.

One final thought: a will does not avoid probate. The word probate actually means "to prove a will." Once someone passes away, their will is supposed to be deposited to the county clerk within 10 days of that person's death. If a probate case is then opened, the assigned judge will determine if the will is valid.






